The Cetnaj Club Powerpoints Terms & Conditions

- Cetnaj Club membership is open to all established account customers of Cetnaj (except government departments, semi-government departments, local government and major corporate bodies).
- To become a member of the Cetnaj Club, you must:
 - (a) Complete an Application Form.
 - (b) Agree to pay an annual membership fee of \$110.00 (inc gst). This fee can be charged to your existing Cetnaj account.
 - (c) Renewals will be an automatic charge on the first day of the month when your membership falls due. The member has 21 days to cancel their membership if no longer required.
- Only one club membership per account number is available. Different account numbers, even if part of same company, require a separate club membership.
- Cetnaj Club members are invited to participate in all Club activities, promotions and benefit schemes that may, from time to time, be offered by Cetnaj.
- Club members may be excluded from any Club promotion at Cetnaj's discretion.
- All benefits of the Club will cease immediately if a member's account with Cetnaj is closed or suspended through non-payment of monies owing. Membership fees will not be refunded in this instance and Cetnaj reserves the right to not award redemptions.
- Upon cancellation of Cetnaj Club membership, either by Cetnaj or Club member, all Powerpoints are null and void and all Club benefits cease.
- The Powerpoints program may be withdrawn at the discretion of Cetnaj management at any time.
- Members cannot redeem Powerpoints accumulated from purchases until those purchases are paid for in full and are paid for within the terms of their account.
- Mobil Fuel Card transactions do not accrue Powerpoints.
- Cetnaj reserves the right to specify that products attract Powerpoints.
- Redemption claims will only be awarded after they have been validated and approved by Cetnaj.
- Where points are redeemed for a third party purchase, a copy of the suppliers tax invoice must be submitted to Cetnaj within 30 days.
- Cetnaj assumes no liability, written or implied, where goods or services obtained via the Powerpoints promotion redemption scheme (or any other Cetnaj promotion) resulting in injury, damage or dispute.
- Point values may be revised in the event of an exceptional price increase. Cetnaj reserves the right to increase/decrease points values at any time without notice.
- Powerpoints are not redeemable for cash or credit.
- Points can be transferred from year to year for a period of five years only.
